We do hereby waive, release, absolve, indemnify and agree to hold harmless Dream Dance Co., the Lakehead Festival of Music & the Arts, the organizers, sponsors, supervisors, participants and persons teaching our/my child and transporting our/my child to and from activities, as well as all owners and co-ordinators of facilities and locations where my child participates in activities associated with Dream Dance Co., from any claim arising out of any injury to our/my child, whether the result of negligence or for any other cause.
- We have read and understand and agree to adhere to the Studio's Code of Conduct (receipt hereby acknowledged) including but not restricted to the Tobacco-Free Policy as well as other policies as stipulated by the Director from time to time.
- We acknowledge that neither teachers nor the Director are responsible for dancers who choose to leave the Studio during breaks.
- We acknowledge payments made after the due date as stipulated by the Director will each result in a penalty fee of \$15.00 for each late payment made within 7 days of the deadline date and \$10.00 will be added to your late fees every additional week. Instruction may be suspended until payment (including late payment fee) is brought current. Cheques returned for insufficient funds will each be subject to a \$25.00 NSF fee.
- We acknowledge refunds are not issued past October 1st, 2018 for first semester, and January 28th, 2019 for second semester. All refunds will be subject to a \$50.00 administration fee.
- We acknowledge that COMPETITIVE DANCERS are obligated to pay, in addition to semester fees, competition fees, costume fees and solo, duet and trio fees, a \$125.00 competitive dancer fee that covers costs associated with extra group practices for competition and costs of travel for teachers and Director.
